To: All Florida Pen Women - Re: Annual Dues Renewal

Hello out there to all branch treasurers. It's getting to be that time of year again. *Each branch is to pay dues annually, **before May 15th**, to the state treasurer for each Active, Associate, International Affiliate, Honorary and Lifetime Member.* If you have Patrons who pay no dues but wish to be placed on the Florida roster, they must also pay the \$6 Florida dues. If you do not pay Florida dues, you will not be on our roster and you may not enter any contests on the state level.

- 1) If you are a member of a Florida Branch, your branch treasurer will contact you about your dues which are due BEFORE May 1st. **If this is your situation, then read no further and wait to hear from your treasurer;**
- 2) If you are a member of a Branch who is without a treasurer, you may mail all of your dues money to me: \$65 for National Dues and \$6 for Florida Dues; you will continue to be on our roster as a member of your branch. I will send National Dues to Washington, DC.
- 3) If your branch has disbanded since the last time you renewed your Pen Women membership with your branch, but you want to become a PenWoman at Large (PAL), you will need to send me: \$65 for National and \$15 for the PAL application and \$6 for Florida. You are considered a PenWoman at Large and will remain on our roster.
